

CHAPTER 6

PARKING REGULATIONS

10-6-1: **PARKING PROHIBITED:** It shall be unlawful for the operator of a vehicle to stop, stand or park such vehicle in any of the following places in the village except when necessary to avoid conflict with other traffic or in compliance with the direction of a police officer or official traffic sign or signal:

- A. In any intersection;
- B. In a crosswalk;
- C. Upon any parkway or area between any roadway and any sidewalk running along or parallel thereto;
- D. Within twenty-five feet (25') of a through street sign on the approaching side;
- E. Within twenty feet (20') of a crosswalk at an intersection;
- F. At any curb within fifteen feet (15') of a fire hydrant;
- G. At any place where the standing of any vehicle will block the use of any driveway;
- H. On any sidewalk;
- I. Along the side or opposite any street excavation or obstruction when such stopping, standing or parking would obstruct traffic;
- J. On the roadway side of any vehicle stopped or parked at the

edge or curb of a street.

10-6-2: **MANNER OF PARKING:** Except when necessary in obedience to traffic regulations or official traffic signs or signals, the operator of a vehicle shall not stand or park such vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of traffic, and with the curb-side wheels of the vehicle within twelve inches (12") of the edge of the roadway unless otherwise designated.

10-6-3: **ILLEGAL PARKING:** Whenever any vehicle is parked in violation of the provisions of this Chapter and there is no person in attendance upon such parked vehicle to be served immediately with a notice to appear before the proper official designated in said notice, to answer the charge of such violation, any person vested with police power by the village witnessing such violation may attach to the vehicle causing such violation, a notification or ticket, so that the person in whose name such vehicle is registered may appear before the proper officer designated in the notice or ticket at the time therein stated to answer to the charge of such violation. It shall be unlawful for any person other than the driver of the vehicle to which such notice is attached to remove the same from said vehicle.

10-6-4: **PENALTY:** Any person violating any of the provisions of this Chapter shall be fined not less than twenty dollars (\$20.00) nor more than fifty dollars (\$50.00) for each offense; and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues. Whenever any vehicle is parked or left standing unattended for a period of seventy-two (72) consecutive hours, the Police Department shall have the vehicle towed away at the owner's expense.

10-6-5: **PARKING RESTRICTIONS:** Parking of any vehicle in excess of 10,000 GVW, fifth wheel truck and trailer, semi-tractor and trailer, semi-trailer or fifth wheel trailer overnight shall be prohibited on any village street.

10-6-6: SNOW REMOVAL PARKING:

- A. A snow emergency is hereby declared to be in effect immediately after two (2) inches of snow has accumulated on the ground and will remain in effect until the snow has been plowed to the curbline.

- B. On all streets in the Village it shall be unlawful for any person, firm, or corporation to stop, stand or park any vehicle during a snow emergency, except that parking will be permitted on even house-numbered sides of streets.

- C. All vehicles not moved within twenty-four (24) hours of the snow emergency to a snow cleared area shall be towed away or moved away by the Village at the vehicle owner's expense.

- D. In order to facilitate plowing of the remainder of the street, those vehicles parked on even house-numbered sides of the street will be moved to the opposite side of the street within eight (8) hours after the snow has been plowed to the curbline.

- E. No snow is to be deposited on any street of the Village in a manner to obstruct a public sidewalk and no such deposit is to be made upon a neighboring parkway or other private property, nor is such snow to hamper vision at any intersection.

- F. No person shall deposit or cause to be deposited, any snow upon any street or alley of the Village on that portion of the traveled way, cleared or scheduled for clearance, of any snow accumulation.

- G. PENALTIES: Any person, firm, or corporation violating any provision of this subsection shall be fined not less than ten dollars (\$10.00) or more than two hundred dollars (\$200.00) for each offense.
